**Saturday, January 30<sup>th</sup>, 2021:** MRSD Deliberative Session will begin at 10:00 a.m. and will be broadcast via Zoom (zoom link can be found at [www.mrsd.org](http://www.mrsd.org) under MRSD Deliberative & Election or on the district homepage calendar).

**Saturday, January 30<sup>th</sup>, 2021:** The MRSD School Board will hold a public meeting starting immediately following the conclusion of the Deliberative Session via the Deliberative Session zoom link (zoom link can be found at [www.mrsd.org](http://www.mrsd.org) under MRSD Deliberative & Election or on the district homepage calendar).

**Saturday, January 30<sup>th</sup>, 2021:** The MRSD Budget Committee will hold a public meeting starting 20 minutes after the conclusion of the Deliberative Session via Zoom. (zoom link can be found at [www.mrsd.org](http://www.mrsd.org) under MRSD Deliberative & Election or on the district homepage calendar).

You are hereby notified to meet at the following locations for the Monadnock Regional School District Deliberative Session on Saturday, January 30, 2021 beginning at 10:00 a.m. for the purpose of hearing an explanation of the School District Warrant Articles and to carry on any discussion or debate with respect thereto, with said warrant articles open amendments.

Supervisors of Checklists will be available in each town location along with District Moderators, and Zoom technology will be used to facilitate the Deliberative Session. **Social distancing and face masks will be required in each of the locations. Registered voters who have a medical condition and/or disability who are unable to wear a mask, and who provide documentation of this limitation, shall be permitted to attend the Deliberative Session as described below. Any non-resident or non-voter who refuses to wear a mask shall not be permitted to attend the meeting at any location.**

Notwithstanding the above, if you are not feeling well and/or are not comfortable wearing a face mask/social distancing, then the District encourages you to stay home and view the meeting via the Zoom link.

In order to actively participate in the Deliberative Session, you must be present at one of the following locations based on your residence.

- **Swanzey & Richmond Voters** will meet at Monadnock Regional Middle High School
- **Fitzwilliam Voters** will meet at Emerson Elementary School
- **Troy Voters** will meet at Troy Elementary
- **Gilsum & Roxbury Voters** will meet at Gilsum STEAM Academy

**Registered voters who have a medical condition and/or disability who are unable to wear a mask, and who provide documentation of this limitation, will all meet at a designated separate area at Monadnock Regional Middle High School, regardless of Town of residence. These attendees will not be permitted to use the main entrance or use school facilities without a mask.**

The meeting will be governed by the Provisions of RSA 40:13. Monadnock Regional Board of Education.
