9:32 PM RSA 91-A:3 II (e) Grievance: The Support Staff Union is filing a Grievance stating a contract violation against the School Board. The violation is hiring the new para- professionals at 5.5 hours. The Support Staff Union is stating the rehires need to be at 7 hours. The Superintendent denied the grievance with the rationale that the hiring of current paraprofessionals at 5.5 hours, as established in the School Board Policy GDF on support staff hiring and it does not violate Article 6.1 (B) which applies to employees in 2001-2002. M. Couture explained policies by the School board cannot be in conflict with the bargaining agreement. The Union is asking for the Board to increase the hires from 5.5 to 7 hours as per the contract and all benefits prescribed. There are 4 individuals involved. M. Alexander explained she knows of 2 staff members at Mt. Caesar. J. Fortson stated one person involved had resigned and came back because of the reduced hours. K. Craig commented that she has hired paraprofessionals are driven by IEPs. M. Couture explained the the paraprofessionals are driven by IEPs. M. Couture explained the contract was intent for the 7 hours a day.

R. Thackston asked M. Alexander and M. Couture to leave while the Board deliberates.

Peterson suggested going all the way. We need flexibility with the staff. P. Bauries said to take the issue as far as needed. Past practice we have hired for less hours an example is the preschool. **VOTE:** 11.956/.693/2.116/.253. **Motion passes.**
